

## Appendix 1 Balance of Debt of Public Sector Accounts




City Bonds to be redeemed by municipal and other taxes

Yokohama has successfully managed to reduce the balance of city bonds to be redeemed by municipal and other taxes in its public enterprise account by reducing the amount of city bond issuances based on its mid-term fiscal plan since the FY 2004.



## Long-term population estimates




Population of Yokohama and estimates in the future
